SIXT entered the US market in 2011 and recently expanded its position as the fourth-largest car rental company in the USA. As a result, SIXT is currently present in the world's largest car rental market with 100 locations and a market volume of more than USD 32 billion in 2019. Only last year, despite the pandemic, SIXT drove forward its expansion strategy by acquiring 10 strategically important airport stations and launching the car subscription SIXT+, setting the course for further growth. SIXT's development in the USA is now underlined by the award, the placement as #3 Car Rental Company showing how the company has stepped up a gear compared to last year's ranking as fourth.

Customers can rent vehicles via SIXT rent from more than 2,000 SIXT stations in approximately 110 countries worldwide. [SIXT rent](#) is available via the SIXT app, which offers in just one app products for car rental in addition to ride hailing and transfer services ([SIXT ride](#)) as well as car subscriptions ([SIXT+](#)). By integrating the services of cooperation partners, the integrated mobility platform ONE gives SIXT customers worldwide access to more than 200,000 vehicles, 1,500 cooperation partners and around 1.5 million drivers.
